- Applicant agrees to accept garbage service in accordance with Ordinance 94-7, amendment 15 for locations within the following: Entities fronting upon or deriving primary access from: Hawkins Street between North Grove Street and Church Street; Church Street between Hawkins Street and West Main Street; West Main Street between Church Street and South Chestatee Street; South Chestatee Street between West Main Street and Choice Street; Choice Street between South Chestatee Street and East Main Street; East Main Street between Choice Street and North Grove Street; and North Grove Street between East Main and Hawkins Street, whereas a minimum monthly fee in the amount of \$40.00 regardless whether a city roll-cart or other container has been assigned.**
