SANITATION RATES MONTHLY

Residential Customers

All households will be charged \$26.62 per month for each garbage can picked up weekly. The cost for additional stickers for each garbage can is \$26.62 per month. Stickers will be placed on all residential cans. All single-family residential units will pay a mandatory minimum garbage collection fee of \$26.62 per month. All other residential units will also pay a minimum garbage collection fee of \$26.62 per month unless served by dumpster service. Rates for non-taxpaying entities not requiring dumpster service will be \$35.09 per month per can.

POLICIES

NEW SERVICE – Parties interested in new service must complete a service application and submit account establishment fee and deposit at City Hall between 8 AM – 4:45 PM, Monday through Friday. An account establishment fee of \$25.00 shall be required for all new connections, hook-ups, and transfers. A deposit of \$250.00 will be charged for all residential accounts where the property is occupied by someone other than the property owner. A deposit of two times the average previous bill for the account will be charged for all commercial accounts.

DISCONTINUE SERVICE -

Termination of Utility Service forms are available on our website, dahlonega.gov, and at City Hall. Please provide a forwarding address for final billing information and deposit refund. The final bill will be deducted from the deposit, and the remainder will be refunded upon notice of forwarding address.

DELINQUENT UTILITY BILLS - A

penalty of **10%** or a minimum of **\$2.00** will be added each month to any bill that has not been paid by the 10th of each month. Discontinuation of service and an administrative fee of **\$75.00** will be added to any bill that has not been paid by the 20th of each month. If the 10th or 20th falls on a day that City Hall will not be open for business, the penalty deadline will be extended to the next working day.

METER TAMPERING - A fee of \$100.00 will be charged if the meter has been tampered with in any way by the customer.

SENIOR CITIZEN DISCOUNT - Upon proper application, a discount will be given of \$15.00 monthly to be applied to the base fee for accounts in which the head of the household is 65 years of age or older. Applicants must also verify through their latest tax return that total household income is less than \$28,170 annually.
